1. The Promoter is Hello Hobart, an initiative of the City of Hobart, 50 Macquarie Street, Hobart Tasmania 7000 ABN 39 055 343 428.
2. Information on how to enter and the prize/s forms part of these conditions of entry. Entry into the competition is deemed acceptance of these conditions of entry.
3. The competition commences on **Thursday 30 November at 2.00pm (EST)** and concludes on **Wednesday 13 December 2017 at 12.00pm (EST)**.
4. Entry to the competition is only available online, through the Hello Hobart Facebook page, www.facebook.com/hellohobarttasmania/.
5. To enter the competition “Like” the Hello Hobart Tasmania Facebook page and comment in the competition post, by telling us what you want for Christmas and which store you can find it in the Hobart city centre.
6. Only entries that correctly mention a store that is located from within the boundary area of the Hello Hobart campaign as defined by item 7, will be deemed as eligible entries.
7. The boundary of the City of Hobart ‘Hello Hobart’ campaign is defined as the area bounded by Harrington, Argyle, Brisbane and Macquarie Streets, including both sides of these streets.
8. There are five prizes to be won, which are each a \$100 voucher to the nominated store, as mentioned in the winning entry. Total value of the prize pool is \$500 inc GST.
9. The prize must be taken as offered. The prize value is GST inclusive and is in Australian dollars.
10. The prize draw will occur at **2.00pm (EST)** at the Hobart Town Hall on **Wednesday 13 December 2017**. The winning entry will be drawn randomly.
11. Entries will be deemed to be accepted at the time they are posted online. No responsibility will be taken for lost, late or misdirected entries.
12. The winner’s names will be published on the Hello Hobart Facebook page.
13. The judge’s decision is final and no correspondence will be entered into.

If the winner has not contacted Hello Hobart and arranged to collect their prize from 50 Macquarie Street Hobart, one week after the competition has been drawn, Hello Hobart reserves the right to award the prize to another entrant by random draw. In the event that for any reason whatsoever a winner does not take an element of the prize at the time stipulated by the Promoter then that element of the prize will be forfeited by the winner.
15. If the prize is unavailable, the Promoter, in its discretion, and in consultation with the winner, reserves the right to substitute the prize with a prize to the equal value and/or specification. If

the nominated store is unable to provide a gift voucher then the winner will be asked to nominate an alternative store in the Hobart city centre.
