2. Information on how to enter and the prize/s forms part of these conditions of entry. Entry into the competition is deemed acceptance of these conditions of entry.
3. The competition commences on **Thursday 6 December 2018 at 2.00 pm (EST)** and concludes on **Monday 17 December 2018 at 12.00 pm (EST)**.

5. To enter the competition comment in the competition post, under the photo of the hamper you would like to win, telling us the why you would like to win the prize and who you would share it with.

There are four individual prizes to be won, including a \$249 hamper from Teros, a \$175 pilates pack from KX Pilates, a \$314 knife pack from Ware Bros Cutlery and a \$200 gift pack from L'Occitane en Provence.
