

## Hobart Souper Bowl 2025 Terms and Conditions

- 1. The 'Souper Bowl' campaign begins at 9:00am AEDT on Friday, 1 August 2025, and ends at 11:59pm AEDT on Thursday, 31 August 2025.
- 2. Hello Hobart, operated by the City of Hobart and located at 16 Elizabeth Street, Hobart, is responsible for promoting the campaign.
- 3. Participants must comply with the Terms and Conditions established by the Promoter, including any future updates.

## THE PRIZES

- 4. Awards will be given to both the top-voted venue and a randomly selected voter.
- 5. The Prize for the Winning Venue consists of:
  - The winning venue will receive a media session with a local agency, valued at \$650. The Prize is sponsored by the Promoter.
- 6. The Prize for the Winning Voter consists of:
  - The selected voter will receive a \$200 voucher valid at any 'Eat and Drink' venue listed on www.hellohobart.com.au.
- 7. Prize winners will be contact after the conclusion of the Promotion, on or after Monday, 1 September 2025.
- 8. A Promoter staff member will randomly choose the winning voter, provided their entry meets all eligibility criteria.
- 9. The venue with the highest number of public votes for its Souper Bowl entry will be declared the winner, subject to eligibility.
- 10. Winners will be notified via phone or email on the draw date and must claim their prize within 14 days.
- 11. Prizes must be redeemed in accordance with the terms specified by the voucher issuer or service provider and cannot be exchanged for cash.



## **HOW TO ENTER**

- 12. Venue participants must, during the campaign period:
  - Develop a soup variety available for purchase throughout the campaign duration.
  - Submit the soup offer via the EOI form and receive approval from the Promoter for valid entry.
- 13. Voting participants must, during the campaign period:
  - Cast a vote for a participating venue using the online voting form.
  - Include their contact information with the vote submission.
- 14. It is the Entrant's responsibility to ensure their entry is submitted correctly and is valid.

## **GENERAL TERMS AND CONDITIONS**

- 15. The Promoter is not liable for entries that are late, lost, incomplete, or misdirected. Entries with incorrect contact details will be invalid.
- 16. The Promoter may disqualify any participant suspected of violating these Terms or engaging in misconduct that compromises the campaign's integrity.
- 17. Winners must present valid identification to claim their prize.
- 18. If a winner is under 18, the prize will be awarded to their nominated parent or guardian upon presentation of photo ID.
- 19. Participants under 18 must obtain parental or guardian consent before entering and be able to provide proof if requested.
- 20. By participating, entrants grant the Promoter permission to publicly announce their name if selected as a winner.
- 21. Hospitality venues within the City of Hobart Local Government Area, as defined by The Local Government Act 1993, are eligible to enter, excluding Promoter staff and their immediate families.
- 22. Southern Tasmanian residents and visitors may vote, excluding Promoter staff, contractors, sponsors, and their immediate families.
- 23. The winner of the major prize must collect their voucher in person from the Council Centre building, 16 Elizabeth Street, Hobart, during business hours, within three weeks of being notified.
